STEEL FIXING & SHUTTERING WORK

Involves securing steel reinforcing bars, also known as rebar and steel mesh used in reinforced concrete construction projects. Following drawings that detail the type of bar and the spacing used is imperative. The reinforcing bars are tied together with wire which is cut using nippers or electric rebar tiers. Shuttering work involves using wooden or steel plates which are temporary structures used in the concrete pouring process.

The temporary created mold will hold the concrete in place as it sets thereby creating a solid smooth structure. A shuttering carpenter is usually trained to work in this specific field

PIPELINE WORKS

GEMC LLC has considerable experience in laying of all types of underground (and above ground pipelines) in Abu Dhabi. We are currently working on the expanded water pipeline project in Abu Dhabi Central Business District. Extra care has to be taken to minimize any damage to existing underground utilities, crew safety due to ever-present hazards. Thankfully our safety track record till date is exemplary while our exposure to unforeseen liabilities is negligible.

WHAT DOES PIPELINE WORK ENTAIL?

Pipelines are primarily used to transport fluids including oil, water & gas besides sewage. Pipelines are also used for utilities including fiber optics, TV / Phone cables and electricity. Different pipelines are used for different application as follows: –

Concrete or plastic Pipes – Best suited for water supply & drainage due to their ability to withstand heavy load, resistance to chemical attack and their durability.

Asbestos cement pipes – Best suited for wastewater & storm water drainage. Asbestos cement pipes have good resistance to hydrogen sulfide corrosion and aggressive soils as it does not have reinforcement steel and reduce operating costs due to low friction factors.

Steel pipes – Best suited for transporting oil & gas from main field to storage tanks, refineries and retail outlets. The larger ones are usually laid above ground, but the smaller pipes are usually laid underground. These pipes can withstand heavy loads & pressure build-up.

Underground pipeline laying work involves

Excavating either manually or mechanically an open trench to our client's requirements, laying & connecting the pipes with appropriate seals, ensuring trench free from water build-up, supporting / protecting all structures, conduits, poles and wires adjacent to the work.

Backfilling entails refilling the excavated trench with soil, aggregate and rocks which is then watered & compacted either with a compactor or even manually to the specification of the client. If surface area is solid concrete then concrete is poured to attain the original finish or in the case of paved surfaced, interlocking
